# INDIA AGAINST NEGATIVITY (IAN)

Prof. Achyuta Samanta has dedicated his life to transformative social initiatives that empower communities, alongside his contributions to education, healthcare, and tribal welfare. His initiatives include outreach programs such as Art of Giving, Kanya Kiran, Nanhi Pari, Education for All, Health Empowerment of Rural Odisha (HERO), New Mind New Dreams, the Kalinga Fellowship and many more. Building on this legacy, he launched India Against Negativity (IAN) as a distinctive platform, a citizen-driven movement that addresses societal attitudes, public discourse, and structural negativity through law, youth activism, and media, aiming to transform society itself rather than providing direct services.

IAN is a transformative civil-society movement founded by eminent educationalist and global humanitarian, Prof. Achyuta Samanta (founder of KIIT, KISS and KIMS). It was formally launched on 31 August 2014 in Bhubaneswar **to promote positivity through purposeful, progressive, and proactive actions for nation-building.** It empowers citizens to recognize, resist, and replace negative forces with constructive alternatives, building a society rooted in positivity, unity, and collective progress. The launch was inaugurated by the then Odisha Chief Minister Shri Naveen Patnaik, with a host of jurists and public figures in attendance (including Justice A. K. Patnaik, Justice M. M. Das, Governor S.C. Jamir, Gajapati Maharaj Dibyasingha Deb, and MPs and MLAs). The forum was described as India's first broad-based effort to protest against negativism and protect the victims of negativity.

IAN's philosophy is grounded in Prof. Achyuta Samanta's lifelong commitment to social work, which demonstrates that compassion and constructive action are stronger than any force of negativity. We believe that every citizen has the power to replace complaint with contribution, fear with courage, and despair with hope. We believe in transformative power of positivity. Negativity thrives when society is fragmented, when the vulnerable are silenced, and when self-interest overrides collective interest. Positivity, on the other hand goes beyond optimism. It is an active, transformative force that unites, builds, and restores.

**Our Path:** IAN is a movement of minds and hearts. Together, we can ensure that negativity has no fertile ground to grow, and positivity becomes the true force shaping India's future. The movement operates on four foundational pillars: Constructive Consciousness (developing solution-oriented thinking), Unified Action (building bridges across communities), Inclusive Progress (ensuring development reaches the marginalized), and Cultural Renaissance (reclaiming India's syncretic traditions). # **Distinguished Guests**

# Shri Faggan Singh Kulaste

Hon'ble Member of Parliament, Lok Sabha; Chairperson, Parliamentary Committee on Welfare of SC and ST and Former Union MoS for Steel & Rural Development

Shri Faggan Singh Kulaste is a seasoned Indian politician and a seven-term Member of Parliament representing the Mandla constituency in Madhya Pradesh. A senior leader of the Bharatiya Janata Party (BJP), he served as Union Minister of State for Steel & Rural Development (2019–2024) and has previously held portfolios including Health and Family

Welfare (2016–2017) and Tribal Affairs (1999–2004). Kulaste began his political career as a member of the Madhya Pradesh Legislative Assembly (1990–1992) and has been elected to the Lok Sabha seven times (1996–2009, 2014, 2019, and 2024), with a brief tenure in the Rajya Sabha from 2012 to 2014. Within the BJP, he has held key leadership roles, including National President of the BJP Scheduled Tribes Morcha and General Secretary of BJP Madhya Pradesh. A committed advocate for tribal welfare, Shri Kulaste has initiated numerous developmental programs, including educational initiatives, cultural preservation, and infrastructure projects in his constituency. He established the Babalia Development Block to support Adivasi communities and promote education.

# H.E. Jacqueline Mukangira

High Commissioner of Rwanda to India

H.E. Jacqueline Mukangira is the current High Commissioner of Rwanda to India, overseeing Rwanda's diplomatic mission in New Delhi. In her role, she also holds concurrent accreditation to Bangladesh, Sri Lanka, the Maldives, and Nepal, strengthening Rwanda's engagement across South Asia. As Rwanda's chief envoy, she is responsible for fostering bilateral relations, promoting trade, investment, culture concertion in areas such as education technology and development.

Mukangira plays a pivotal role in representing Rwanda's interests, facilitating high-level dialogues, and enhancing diplomatic collaboration between Rwanda and the countries under her jurisdiction. Her leadership has been instrumental in advancing Rwanda's international partnerships and reinforcing its presence in the South Asian region.

# Hon'ble Mr. Justice Debabrata Dash

Judge, Orissa High Court

Justice Debabrata Dash is a distinguished Judge of the Orissa High Court. A First Class Physics (Hons.) graduate from MPC College, Baripada, he earned his LL.B. from Utkal University in 1984 and began practice under the guidance of his father, Late Harekrushna Dash. After 18 years at the Bar, he

joined the Orissa Superior Judicial Service in 2003, serving in key positions including District & Sessions Judge, Legal Remembrancer, and Principal Secretary, Law, Government of Odisha. On 29 November 2013, he was elevated as Judge of the Orissa High Court, where he continues his service to justice.

# Hon'ble Mr. Justice Ananga Kumar Patnaik

Former Judge, Supreme Court of India and Chairman, IAN Advisory Board

Justice Ananga Kumar Patnaik is a distinguished jurist and former Judge of the Supreme Court of India, widely respected for his expertise in Constitutional and Commercial Law. Enrolled as an advocate in 1974, he practiced before the Orissa High Court, subordinate courts, tribunals, and the Supreme Court of India. He served as Standing

Counsel for the Orissa State Road Transport Corporation and later as Senior Standing Counsel for the Commercial Taxes Organisation, Government of Orissa. He was elevated as a Judge of the Orissa High Court in 1994, later transferred to the Gauhati High Court, where he became a permanent Judge in 1995. After serving eight years in Gauhati, he returned to the Orissa High Court in 2002, where he also headed the Orissa State Legal Services Authority and the Orissa Judicial Academy. He was appointed Chief Justice of the Chhattisgarh High Court in 2005 and subsequently the Madhya Pradesh High Court. In November 2009, he was elevated to the Supreme Court of India, where he served with distinction until his retirement in June 2014.

# Hon'ble Mr. Justice N. Santosh Hegde

Former Judge, Supreme Court of India and IAN Advisory Board Member

Justice Nitte Santosh Hegde is a distinguished jurist, former Judge of the Supreme Court of India, and former Lokayukta of Karnataka, widely admired for his integrity and commitment to justice. Son of Justice K. S. Hegde, he pursued his education at St. Aloysius College, Madras Christian College, and Government Law College, Bangalore,

where he earned his law degree in 1965. Beginning his legal career in 1966, he rose to prominence as Advocate General of Karnataka in 1984, Additional Solicitor General of India (1989), and Solicitor General of India (1998). In 1999, he was elevated to the Supreme Court of India, where he served with distinction until his retirement in 2005. In 2006, Justice Hegde took charge as Lokayukta of Karnataka, where his bold investigations exposed large-scale corruption and illegal mining, earning him national respect as a fearless crusader for accountability and transparency. His work significantly influenced policy debates on governance and environmental protection. Post-retirement, Justice Hegde continued his public service by joining the nationwide anti-corruption movement in 2011, inspiring millions with his steadfast dedication to ethical leadership.

# Hon'ble Mr. Justice B.P. Das

Former Judge, Orissa High Court

Justice B.P. Das graduated from Ravenshaw College and completed his M.A. in Political Science (1972) and LL.B. (1974) from Utkal University. He began his legal career in 1974 as an associate of Senior Advocate Shri Bijoy K. Mahanti and started independent practice in 1979. With extensive experience in constitutional, civil, criminal, taxation, revenue, labour, and environmental law, he represented numerous institutions, corporations, and private clients, serving as Senior Counsel for the State Pollution Control Board. A member of the Orissa State Bar Council (1996–1997), he also served as Additional Government Advocate before being elevated as a Permanent Judge of the Orissa High Court on 17 June 1999, where he contributed significantly to justice and legal development in the state.

# Hon'ble Mr. Justice M.M. Das

Former Judge, Orissa High Court

Justice Madan Mohan Das comes from a family of lawyers and is the son of renowned Senior Advocate Shree Madhabananda Das. He completed his H.S.C. in 1967, graduated in Chemistry (Hons.) from Ravenshaw College in 1971, earned an M.A. in Public Administration from Utkal University, and obtained his LL.B. from M.S. Law College. He joined

the Bar in 1974 and practiced for 29 years, handling important civil, criminal, and constitutional cases. He served as a retainer for the State Bank of India and other nationalised banks and actively supported social, philanthropic, and spiritual organizations. Elevated as a Judge of the Orissa High Court on 20 November 2003, he served with distinction until 4 February 2014, contributing significantly to justice and legal development in the state.

# **Shri Ashok Parija**

Senior Advocate, Supreme Court of India and Former Advocate General of Odisha

Shri Ashok Kumar Parija has built a distinguished legal career, recognized for his expertise, leadership, and service to the profession. He was appointed Advocate General of Odisha in 2019, served as Chairman of the Bar Council of India (2011–12), and led the Odisha High Court Bar Association as President. He has represented clients before the

Supreme Court of India, multiple High Courts, statutory bodies such as the Central Electricity Regulatory Commission and the National Consumer Forum, and international arbitration forums, including the International Chamber of Commerce and the Singapore Chamber of International Arbitration. He has also been appointed as arbitrator by the Supreme Court, the Orissa High Court, and prominent public and corporate entities. A recognized authority in constitutional, corporate, mining, and environmental law, Shri Parija has initiated significant reforms in legal education and led philanthropic projects to support the legal community. He earned his LL.B. from Utkal University in 1984 and trained under Senior Advocate Gangadhar Rath. Designated as a Senior Advocate at the Orissa High Court in 2003, he combines legal expertise with simplicity, diligence, and integrity, inspiring lawyers across India through his professional achievements and unwavering commitment to justice.

# Shri Manas Mohapatra Senior Advocate, Supreme Court of India

Shri Manas Mohapatra is a distinguished Senior Advocate practicing at the Supreme Court of India, representing the highest echelons of legal excellence in the country. With extensive experience in constitutional law, civil matters, and appellate litigation, he has handled numerous landmark cases

before the apex court. His legal expertise and advocacy skills have earned him recognition among the senior members of the Supreme Court Bar. # Prof. Ghanta Chakrapani

Shri Ketkar's academic journey includes a Master's degree in Political Science from the University of Pune and an M.Phil. in International Politics from Jawaharlal Nehru University, New Delhi. He has taught as Assistant Professor and Head of Department at a Pune college and worked with renowned research institutions like the Institute of Peace and Conflict Studies. He has been part of several national bodies, including the Indian Institute of Mass Communication, Delhi School of Journalism, and Prasar Bharati's Advisory Committee for Azadi Ka Amrit Mahotsav. Recognised with the Maharshi Ved Vyas Samman (2022–23) by the Government of Madhya Pradesh, Shri Ketkar is also a regular television panelist and an influential public speaker on Bharatiyata and India's civilisational values.

# Shri Ashok Srivastava

Senior Consulting Editor and Anchor at DD News

Shri Ashok Srivastava is the Senior Consulting Editor and anchor at DD News, hosting the highly popular primetime show *Do Tuke* from 9 to 10 PM daily. He is also an accomplished author, with his latest book *Modi vs Khan Market Gang* topping the political bestseller lists for several months, following his widely discussed 2019 publication *Narendra Modi Censored*. With nearly three decades in journalism,

Shri Srivastava began his career with newspapers like Navbharat Times and Panchjanya before moving to television. Renowned for both anchoring and field reporting, he has covered complex issues in Kashmir, Ayodhya, and West Bengal since 1993 and reported on the international visits of Prime Ministers Atal Bihari Vajpayee, Manmohan Singh, and Narendra Modi. He is a TEDx speaker and has been honored with the Bharat Gaurav Award at the UK Parliament and recognition from the Mangalam Swaminathan Foundation for his outstanding contributions to journalism.

Known for socially conscious films such as Bettada Jeeva and Mookajjiya Kanasugalu, he has received acclaim at national and international film festivals. Sheshadri has also directed documentaries, television serials, served on juries, and received the Karnataka State Lifetime Achievement Award.

# **Down Memory Lane:**

# Launch of India Against Negativity (IAN), 2014



The nationwide movement India Against Negativity (IAN) was formally launched on 31st August 2014 in Bhubaneswar, marking the beginning of a unique forum dedicated to countering negativism and encouraging a spirit of positivity in public life. Conceived and convened by Dr. Achyuta Samanta, Founder, KIIT, KISS & KIMS, IAN is the first organized platform of its kind to protect individuals from the impact of negativity and promote constructive thinking across society. The inaugural ceremony was graced by a galaxy of dignitaries, including the then Chief Minister of Odisha Shri Naveen Patnaik, Justice A. K. Patnaik (Retd.), Supreme Court of India, Justice M. M. Das (Retd.), Orissa High Court, Gajapati Maharaj Dibyasingha Dev, Mps, MLAs, renowned social activist Jokin Arputham, and many eminent personalities from diverse fields.

# **Message of Positivity**

Launching the forum, Shri Naveen Patnaik described IAN as a noble initiative at a time when society needed to unite against negative tendencies. He urged people to consciously choose positivity over pessimism, remarking, "Positive and negative mindsets are both within us. One makes us, the other breaks us. A small negative thought can become a fireball of ugliness, but a small positive thought can blossom into a garden of Gods." He stressed that negativism weakens confidence and clouds vision, likening it to "a drop of poison in the nectar of positivism." Former Supreme

Court Judge Justice A. K. Patnaik, who chaired the Advisory Board of IAN, emphasized that Odisha was the right place for this initiative, recalling how the late Biju Patnaik had worked to eradicate negativism from public life. Justice M. M. Das, Vice-Chairman of the Advisory Board, went a step further, saying the forum would help people remove the word "no" from their lives.

### Voices from the Forum

Many distinguished speakers at the launch echoed the central theme of overcoming negativity. They hailed the efforts of Dr. Samanta and denounced those driven by jealousy who sought to malign individuals striving for noble causes. Gajapati Maharaj Dibyasingha Dev underlined spirituality as a powerful means to eliminate negativism, while senior bureaucrat Sudhanshu Bhusan Mishra observed that negativity was often more common among the educated elite than the downtrodden. Panelists such as Swami Shibachidananda Saraswati, Swami Atma Pravananda, Rajaram Satapathy (The Times of India), and Prof. N. L. Mitra deliberated on how negativity blocks individual and societal progress, suggesting ways to cultivate positivity for the development of the nation. Other contributors included senior administrators, parliamentarians, academics, activists, and writers, who all reinforced the urgency of uniting against negativism.

# **Building a National Movement**

The event saw participation from nearly 2,000 people from all walks of life, reflecting the broad support for the mission of IAN. Dr. S. C. Jamir, Governor of Odisha, in his valedictory address, identified discrimination, jealousy, and bureaucratic delays as key sources of negativity and urged a balance between negative and positive forces. Media leader Soumya Ranjan Patnaik further cautioned that negative-minded people often form powerful groups to stifle positive voices, calling upon citizens to stand together against such trends. IAN was launched as a pan-Indian forum headquartered in Bhubaneswar, with seven national branches in New Delhi, Mumbai, Kolkata, Chennai, Bangalore, Ranchi, and Patna, and regional branches in all 30 district headquarters of Odisha. Remarkably, within just a week of its inception, the forum had attracted over 10,000 members, reflecting its immediate resonance with the public.




